#### **THE TRAINING IS INTENDED FOR**

The office and administration employees, sales representatives, teachers, medical services and others not mentioned.

#### **THE FREQUENCY OF PROVIDING THE TRAININGS**

The first training is provided within a year from employment of a worker, then every 6 years.

#### **HOW IS THE TRAINING ORGANIZED?**

Occupational Health and Safety e-learning – an on-line training with the use of multimedia, graphics, charts etc. The training consists of seven modules, each of them ended with a quiz consisting of one or two questions related to the thematic scope of the given module. Occupational Health and Safety course is finished with an on-line exam: there are 15 easy questions (questions from quizzes). There is no time limit during solving the test.

The training may be stopped at any time by clicking on the red cross in the upper, right corner and when coming back to the training you are returning to the last viewed slide.

The training is prepared with the voice of a reader – there is a possibility to turn off the sound in order to read the text faster.
